## DIRECTIONS TO THE OTESAGA

### COOPERSTOWN

### FROM POINTS WEST

Take Exit 30 off of the New York State Thruway (I-90) at Herkimer and take Route 28 South to Cooperstown. After entering the village, turn left onto Chestnut Street. Follow Chestnut Street through the stop light to Lake Street. Turn left at Lake Street. The Otesaga is located on the right overlooking Lake Otsego.

### FROM POINTS EAST

Take the New York State Thruway (I-90) to Exit 29 at Canajoharie, take Route 10 South to Route 20 West to Route 80 South into Cooperstown OR take the Thruway (I-90) to Exit 25A and I-88 to Exit 24 (Duanesburg) then Routes 20 and 80 to Cooperstown. After entering the village, The Otesaga is on the left, just past the golf course on Lake Street.

### FROM SOUTH/SOUTHERN TIER

Take I-88 East to Oneonta, Exit 17 to Route 28 North to Cooperstown. After entering the village follow Chestnut Street through the stoplight to Lake Street. Turn left onto Lake Street. The Otesaga is located on the right overlooking Lake Otsego.

## GRANTMAKERS FORUM OF NEW YORK MEMBERSHIP
